



Alternatives to AARP Free Tax Aide

Due to COVID-19, all AARP Tax Aide/ VITA sites and TCE sites in Oregon are closed for an undetermined period of time.

This year's deadline to file and pay has been changed from April 15th to July 15th per the US Treasury and IRS news Release: [IR-2020-58](#), **Tax Day now July 15**: Treasury, IRS extend filing deadline and federal tax payments regardless of amount.

If you will be unable to file and pay by the July 15th deadline, you can request an automatic 6-month extension of time to file your return. You must file [Form 4868](#), Application for Automatic Extension of Time To File U.S. Individual Income Tax Return (PDF) by the due date (July 15th, 2020) of your return.



Below are some free alternatives for filing your taxes if you have internet access. If you have the ability to do your taxes online and you made less than \$69,000 in 2019, you may be able to use one of the providers listed below:

Note: Some, but not all, offer free state returns, some have age restrictions.

Free 1040 Tax Return

Receive a free Federal return if:

- Your Adjusted Gross Income is \$69,000 or less, **AND**
- Your age is 70 or younger, **AND**
- Live in any state, EXCEPT: DC, FL, IN, LA, MT, NH, NM, NV, RI, SD, TN, TX or WA, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less

Free state return, for some states, if you qualify for the federal return

H&R Block & MyFreeTaxes.com

Receive a free Federal return if:

- Your Adjusted Gross Income is \$69,000 or less, AND your age is between 17 and 51, **OR**
- You are eligible for the Earned Income Tax Credit, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return if you qualify for the federal return

TurboTax

Receive a free Federal return if:

- Your Adjusted Gross Income is \$36,000 or less, AND any age, **OR**
- You are eligible for the Earned Income Tax Credit, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return if you qualify for the federal return

[FileYourTaxes.com](https://www.fileyourtaxes.com)

Receive a free Federal return if:

- Adjusted Gross Income is between \$9,000 and \$69,000, AND your age is 65 or younger, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return, for some states, if you qualify for the federal return

Receive a free Federal return if:

- Your Adjusted Gross Income is \$36,000 or less, AND any age, **OR**
- You are eligible for the Earned Income Tax Credit, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less

Free state return, for some states, if you qualify for the federal return

[TaxAct](https://www.taxact.com)

Receive a free Federal return if:

- Your Adjusted Gross Income is \$59,000 or less AND your age is 56 or younger, **OR**
- You are eligible for the Earned Income Tax Credit, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return if you qualify for the federal return

[TaxSlayer®](https://www.taxslayer.com)

Receive a free Federal return if:

- Your Adjusted Gross Income is \$69,000 or less AND your age is 51 or younger, **OR**
- You are eligible for the Earned Income Tax Credit, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return, for some states, if you qualify for the federal return

[1040NOW](https://www.1040now.com)

Receive a free Federal return if:

- Your Adjusted Gross Income (AGI) is \$69,000 or less and you live in one of the following states: AL, AR, AZ, CA, GA, IA, ID, KY, MI, MN, MO, MS, NC, ND, NY, OK, OR, RI, SC, VA, VT or WV, **OR**
- Your AGI is \$68,000 or less and you live in CO, CT, DC, DE, HI, IL, KS, LA, MA, MD, ME, MT, NE, NJ, NM, OH, PA, UT or WI, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less

No free state tax preparation in any states

Receive a free Federal return if:

- Your Adjusted Gross Income is between \$14,000 and \$69,000, AND any age, **OR**
- Free for Active Military for Adjusted Gross Income of \$69,000 or less
- Same criteria apply when filing with a foreign address

Free state return if you qualify for the federal return

Receive a free Federal return if:

- Your Adjusted Gross Income is \$69,000 or less, AND any AGE, **AND**
- You live in one of the following states: AL, AR, AZ, CA, CO, GA, IL, LA, MA, MD, MI, MO, MS, NC, NJ, NY, OH, PA, SC, VA, or WI

No free state tax preparation in any states.
