Computers (including adaptive technology computers), Wi-Fi, and device charging stations, are available inside the **Downtown Library** for one-hour appointments. These services are free and no library card is needed. Appointments can be made for the same day or the next day.

One appointment per person per day. Reserve an appointment time by phone: **(541) 682-5450** or in person.

**Downtown Library computer appointment hours:**

Monday, Tuesday, Friday, and Saturday, 10am-6pm

Wednesday and Thursday, 12pm-8pm



Library computers are available for working on your taxes. Call **(541) 726-3766** to make an appointment. Library staff are NOT able to assist you with tax preparation, including helping you select which forms you need. Only certified tax professionals can legally offer tax advice. Library staff are happy to help connect you to tax resources and offer computer and printing help when possible. Tax forms are available at the library during tax season.

- The federal Forms 1040, 1040 EZ and the instruction booklet are available for free
- A limited number of Oregon OR-40 forms are also available for free
- **To pick up forms, you may come to the library's front doors during:**
  - Curbside pickup hours: 1:00-3:00, Mon-Sat  
OR
  - Computer appointment hours:  
Monday, Wednesday, and Thursday, 4pm-6pm  
Tuesday, Friday, and Saturday, 10am-12pm
- All other federal forms and booklets, as well as state forms and instruction booklets, can be printed at the library for \$0.15 cents per page. Please call the library to arrange for printing and pickup.
